## 1. Opening.

- a. Kirk Klinger led the opening prayer.

The motion carried.
- 4. Anne discussed making improvements to the big playground. The vestry decided to seek parishioners interested in serving on a task force. Anne will write a blurb for newsletter and bulletin.
- 5. Dawn discussed sharing vestry meeting news with the congregation.
- 6. The Rev. Kirchmier divided the vestry into groups to discuss how individual goals are progressing.
- 7. The Rev. Kirchmier discussed pages 19-67 of the Signs of Life Nurturing Spiritual Growth in Your Church book and asked the vestry for their comments.
- 8. On June 11, 2025 the vestry voted via email to pay for the roof repair from our composite fund.
